The filing of Temasek's deemed interest arises from the aggregation of the deemed interests held by Keppel Corporation Limited ("KCL"), DBSH and Fullerton Fund Management Company Ltd. ("Fullerton").

(A) Temasek's deemed interest via KCL 35.109% Keppel DC Investment Holdings Pte. Ltd. ("Keppel DC Investment") (i) holds 30.0406% of the Units. Keppel DC Investment is a subsidiary of Keppel Data Centres Pte. Ltd. which in turn (ii) is a subsidiary of Keppel Telecommunications & Transportation Ltd which in turn is a subsidiary of KCL. (iii) KCL through two other subsidiaries has a deemed interest in 5.0686% of the Units. (iv) Temasek has a more than 20% interest in KCL.
