The change in Temasek's deemed interest is due to payment of management fee by way of issue of units to Keppel REIT Management Pte Ltd ("KRMPL"). KRMPL is an indirect subsidiary of Keppel Corporation Ltd ("KCL"). Temasek's deemed interest in the units arises from the aggregation of deemed interests of KCL and DBS Group Holdings Ltd ("DBSH"). KCL and DBSH are independently managed Temasek portfolio companies.

(iii) KCL and 2 other subsidiaries hold 3.12% of units.	
(iv) Temasek has a more than 20% interest in KCL.	
(B) Temasek's deemed interest via DBSH	0.44%
(i) DBSH through its subsidiary, DBS Bank, hold 0.44% of units.
